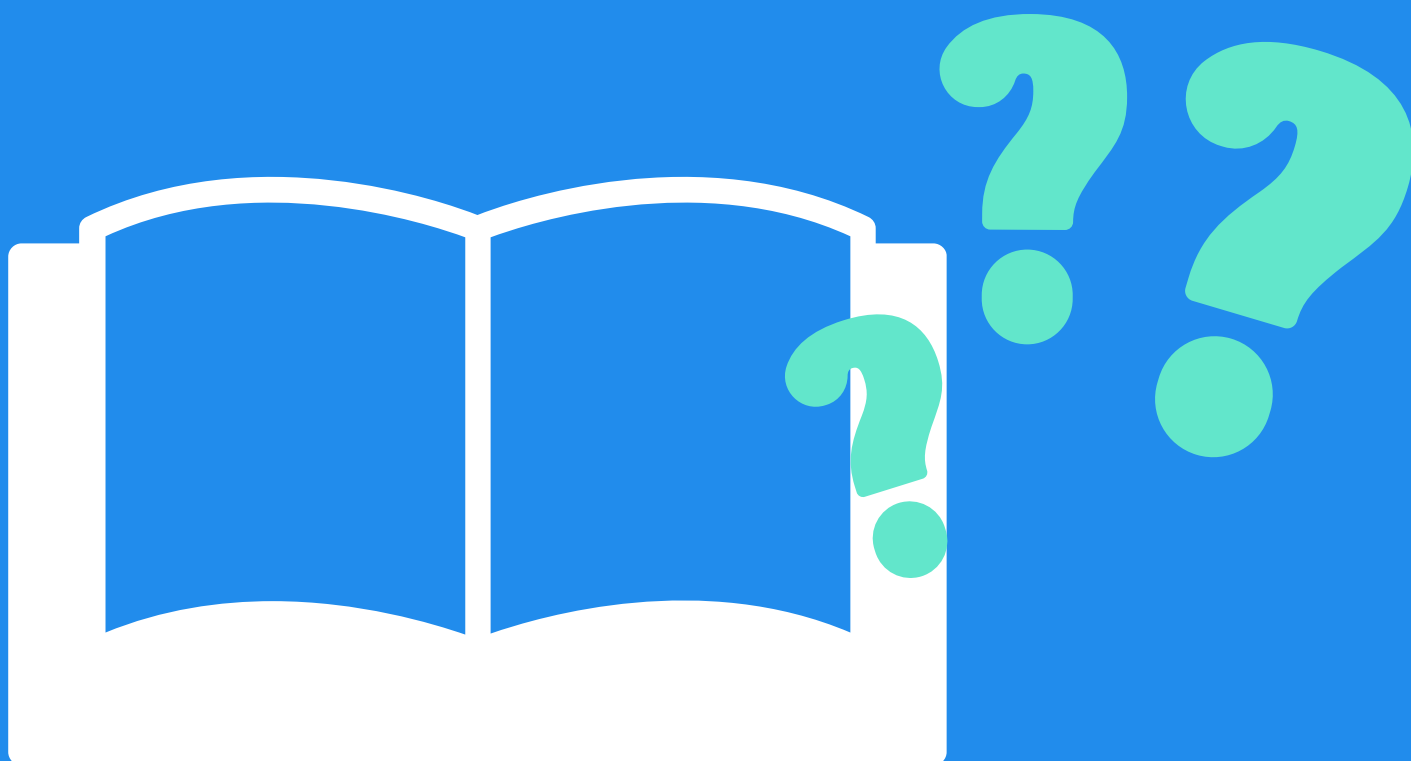

# INTRODUCTION



Words are important right now - everyone has the right to choose the language they want to use. It is neither the right, nor the place of a British education charity to make rulings on geo-political issues, it is the place of international governments and courts.

Therefore, rather than tell people what terminology we think they should or shouldn't use (beyond our anti-racism guides), we will present in this guide some information about statements from the United Nations (UN), of which the UK is a member, and also British Government positions, so that people can come to an informed decision for themselves.

This information may also change over time as events develop, and we are committed to update our curriculum and resources regularly.

# GLOSSARY



## Apartheid:

The United Nations, through its human rights experts, has described Israel's actions in the occupied Palestinian territories as constituting apartheid. In March 2022, Michael Lynk, a UN Special Rapporteur, stated that Israel's policies in these territories meet the international legal definition of apartheid[1][3]. Additionally, other UN experts and reports have echoed this assessment, highlighting a system of racial oppression and discrimination against Palestinians[5][7]. These findings align with reports from various international human rights organizations[2][6]. The UK Government has not applied this label to Israel's actions, but does view the occupation as illegal under International Law (see below).

### **Colonial:**

The United Nations has described Israel's occupation of Palestinian territory as indistinguishable from a "settler-colonial" situation. A UN independent expert stated that this occupation must end to allow Palestinians to exercise their right to self-determination[2]. Additionally, a UN special rapporteur mentioned that Israel treats Palestinian territories like colonies[7]. These statements reflect the UN's perspective on Israel's actions in the occupied territories, aligning them with characteristics of settler colonialism. The UK Government has not described Israel as 'colonial'.

### **Ethnic Cleansing:**

A UN official has accused Israel of ethnic cleansing. Francesca Albanese, the UN Special Rapporteur on human rights in the Palestinian territories, stated that Israel practices ethnic cleansing by removing Palestinians from their homes and historic lands[3]. Additionally, a UN human rights investigator has accused Israel of "ethnic cleansing" in pushing Palestinians out of East Jerusalem[6]. These accusations have been made in the context of ongoing conflicts and military operations involving Israel and the Palestinian territories. The UK Government has not accused Israel of ethnic cleansing.

## Genocide:

The International Court of Justice (ICJ) has found that allegations of genocide are plausible and ordered Israel to take measures to prevent genocidal acts. However, so far, neither the UK Government, nor the ICJ has stated that genocide is occurring in Gaza.

### **Holocaust:**

Neither the UN nor the UK Government describe Israel's actions as perpetrating a 'Holocaust'. This term was applied to the Nazi genocide for specific reasons due to the meaning of the Greek term that is the linguistic root of this word and the methods of killing used in that genocide. Therefore, applying this term would be a hurtful 'dig' at Jewish people, as Israel is a majority Jewish state, and the main targets of the Nazi genocide were Jews. ## Israel and Palestine:

The United Nations (including the UK) recognises Israel. Israel was admitted as a member of the UN on May 11, 1949, following a vote in the General Assembly that approved its application for membership[1] [2]. However, not all UN member states recognise Israel as a sovereign nation; as of December 2020, 165 out of 193 UN member countries recognised Israel[2].

The United Nations (including the UK) does not fully recognise Palestine as a member state but acknowledges it as a non-member observer state. As of June 2024, 146 out of 193 UN member states recognise Palestine as a sovereign state[1][2]. The UN General Assembly granted Palestine this observer status in 2012, which allows participation in debates but not voting rights[2][4]. Despite broad recognition, Palestine's full UN membership is hindered by the United States' veto power in the Security Council[2].

### **Martyrdom:**

Neither the UN nor the UK Government glorify violence by individuals on either side as 'martyrdom'.

### **Nakba:**

The United Nations has adopted the term "Nakba" to describe the events of 1948, which involved the mass displacement and dispossession of Palestinians during the Arab-Israeli war. The term is used to highlight both historical and ongoing injustices faced by Palestinians. In 2023, the UN held its first-ever commemoration of Nakba Day, marking its recognition of the term and its significance in Palestinian history[1][2][3]. The UK Government has not officially adopted the term "Nakba" in its governmental discourse or policy.

## Occupation:

The United Nations views Israel's presence in the Palestinian Territories as an occupation. The UN General Assembly recently passed a non-binding resolution demanding that Israel end its "unlawful presence" in the Occupied Palestinian Territory within a year[1][2][5]. This resolution reflects the UN's stance, supported by an advisory opinion from the International Court of Justice, which also declared Israel's actions in these territories as illegal under international law[1][2].

The UK Government also views Israel's presence in the Palestinian Territories as an occupation. The UK Government consistently refers to these areas as the "Occupied Palestinian Territories" and considers Israeli settlements there illegal under international law[1][2]. The UK has called for Israel to end its presence in these territories, aligning with the International Court of Justice's advisory opinion that deems the occupation unlawful[3][4]. The UK advocates for a negotiated two-state solution to resolve the conflict[2].

## **Terrorist [Applied to Hamas]:**

The United Nations has not officially designated Hamas as a terrorist organisation. A top UN official, Martin Griffiths, stated that "Hamas is not a terrorist group for us," referring to it as a political movement[2]. This position contrasts with many countries, including the United States, European Union, and Israel, which have designated Hamas as a terrorist organisation[1][3]. There have been calls from various entities for the UN to recognise Hamas as a terrorist group, but it remains off the UN Security Council's list of designated terrorist organisations[3].

However, the UK Government has designated Hamas as a terrorist organisation under the Terrorism Act 2000[1][4][5].

## **Terrorist [Applied to certain Jewish settlers in the West Bank]:**

Neither the UN nor the UK Government has explicitly referred to any West Bank Jewish settlers as "terrorists," but the UK has imposed sanctions on extremist Israeli settlers involved in violence against Palestinians in the West Bank[1]. These sanctions include financial and travel restrictions targeting individuals who have committed human rights abuses[1]. While the UK Government has condemned settler violence and called for accountability, it has not officially labelled the settlers as terrorists[1][2].

## War Crimes:

The International Criminal Court (ICC) has not yet concluded any cases regarding war crimes by Israel or Palestine. An investigation was opened in 2021 into alleged war crimes by Israeli military forces and Palestinian armed groups, including Hamas, since June 2014[1]. Arrest warrants have been requested for leaders from both sides, including Israel's Benjamin Netanyahu and Hamas's Yahya Sinwar[2].
